- To recommend / initiate enforcement action against non-compliant entities under supervision within the jurisdiction allowed under the securities laws.
- To submit necessary reports to BSEC and any other authority if required.
- To investigate the affairs of the listed companies with prior approval of Bangladesh Securities and Exchange Commission.

## Requirements for the position of Manager/Assistant General Manager

- MBA (preferably majoring Accounting / Finance) from any renowned Public or Private University is a must;
- Achievement or pursuit of professional qualification (e.g. CA, CMA, CS, CFA etc.) will get preference.
- Candidates having sound literacy on regulations, rules, and laws governing financial markets, capital markets, and stock exchange will get preference;
- Minimum 5 years (for Manager) and 8 years (for Assistant General Manager) of practical experience in a financial service-oriented organization or capital market;
- Age must not exceed 45 years as on last date of submission of application.
- The requirements may be relaxed for extra ordinary candidates.
