




19.10.2023	THURSDAY	Put up final list of voters and names of Corporate Representative on the CSE Notice Board and Website by 5.30 p.m. [At least 20 days prior to the election as per clause 6(v) of the Guidelines]
22.10.2023	SUNDAY	Strat distribution of Nomination Form

13.11.2023	MONDAY	a) Last date of receiving objections against the candidates if any, by 5.30 p.m.[Within 2 days of posting of provisional list of candidates as per clause 10(2)of the Guidelines] b) Last date of receiving Notice of withdrawal if any, by the candidates, by 5.30 p.m.[Within 2 days of posting of provisional list of candidates as per clause 11 of the Guidelines]
16.11.2023	THURSDAY	Put up final list of candidates on CSE Notice Board and Website by 5.30 p.m. [within 2 days from the date of expiry of withdrawal date as per clause 12 of the Guidelines]
20.11.2023	MONDAY	Last date of receiving the instrument appointing proxy to the Exchange by 4.00 p.m. (Article 105) [Seventy two (72) hours before the time for holding the meeting]
23.11.2023	THURSDAY	Election Day - Polling Hours from 10.00 a.m. to 03.00 p.m. [As per clause 25 of the Guidelines and Board decision]
